

Regulation No. 152/2020 of the Rector of the University of Opole of November 13, 2020

on the rates of student benefits at the University of Opole in the academic year 2020/2021

Pursuant to Article 95(1)(1) of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2020, item 85 as amended), in connection with **Section 9(1)(2) and (3)** of the Rules on benefits for students and doctoral students at the University of Opole (Appendix 1 to Regulation No. 104/2020 of the Rector of the University of Opole of 15 September 2020 on the Rules on benefits for students and doctoral students at the University of Opole), the Rector of the University of Opole orders as the following:

§ 1

1. The rates of student benefits for the academic year 2020/2021 shall be set as follows:

§ 2

In particularly justified cases referred to in **Section 13(2)(1-4)** of the Rules of benefits for students and doctoral students at the University of Opole, a student may receive a maintenance grant of an increased amount (up to PLN 300) if his/her family per capita income does not exceed PLN 1051.70 net.

§ 3

- 1. Rector's Scholarship is awarded to no more than 9.5% of students of each study programme with no breakdown into years, or the mode (full-time, part-time, or evening), and with a breakdown into cycles of studies. The number of points is calculated on the basis of the "Criteria for Rector's Scholarship" and the "Commentary on the criteria for granting the Rector's scholarship", constituting Appendix No. 1 and No. 2 to the *Rules on benefits for students and doctoral students of the University of Opole* respectively.
- 2. The following thresholds are set for the Rector's scholarship:
 - 1) **Threshold I** shall mean the student with the highest number of points;
 - 2) **Threshold II** shall mean no more than 3% of top students in each programme, excluding those in threshold I;
 - 3) **Threshold III** shall mean no more than 6% of top students in each programme, excluding those in thresholds I and II;
 - 4) **Threshold IV** shall mean no more than 9.5% of top students in each programme, excluding those in thresholds I, II and III.

§ 4

The maximum amount of the aid is 800 PLN.

§ 5

The rates of student benefits have been agreed with the Students' Union of the UO.

§ 6

The regulation shall enter into force on the date of signature with effect of 01 October 2020.
